REVIEW OF NOVEMBER MINUTES:

Motion: Ann moved. Sue seconds. No Discussion. All in favor.

FINANCIAL REPORT:

Motion: Candice ☐ Keep \$35,000 in checking, and move \$52,342.44 over to Money Market account in Incredible Bank. Jeff seconds. No Discussion. All in favor.

OLD BUSINESS:

- 1. Update Bylaws: BOD applicant requirements, optional 2nd remote position.
 - a. Most updated Nov 2019 says only a 6 month member rather than a 1 year
 - b. Julie motions, David seconds, All in favor to amend the current bylaws as follows:
 - i. CONFIRM WORDING FROM THE NOTEBOOK THAT SUE READ FROM
 - ii. A board applicant must maintain membership for 12 months prior to applying
 - iii. Must be a member in good standing

- iv. Have volunteered at the festival for a minimum of 3 hours or have a history of volunteering at Hiawatha committees/events
- 2. Early Entry AC Position Erin Putvin-Leahy
 - a. Sue Dorman and Karen Baccula
- 3. Review SAIL doc and assign MACC funds accordingly
 - a. David spent a lot of time with the document and is going to come down to cost and what are we going to apply vs what we put back on SAIL to provide for an event
 - b. Ann suggests to pay them for 1 hour of their consulting time and see what is going to cost what. Some of them are going to be extremely expensive, and more of a County update.
 - c. Terri the 3 main areas we have \$18,5000 to utilize
 - i. \$19,500 on performer fees (minority, indigenous, etc) 75% of that is \$14,625 towards performer fees
 - ii. \$750 Accessible restrooms, \$750 in tents, \$1500 veterans and caregivers, \$75 in participant comfortable in sensory
 - a. 2 marked accessible in dance tents, 3 at main state
 - iii. \$ xx marketing
 - d. David https://www.NoJazzFest.com/patrons-with-disabilities has attention to accessible bathrooms, guide dogs, etc We should really do this on our website.
 - e. Ann have a designated area where those with disabilities can get all the info that they need

Motion: Sue moves to explore consulting with SAIL, with an expense to be up to \$1,000 in cost. Melinda seconds. No Discussion. All in favor.

NEW BUSINESS:

- Change code twice a year Entry Log
 - a. Julie some concerns that we change the code and everyone signs a log who has been in. Everyone agrees.
- 2. Purchase a Coffee Cart & Round Table
 - a. Coffee Cart Julie it is apparent that we could benefit from having one for all of our events in the future. The most expensive one is \$350

Motion: Julie would like to purchase a cart and spend up to \$350. Ann Seconds. All in favor.

- b. Round tables Sue we need foldable tables we could fit more people in here, at least 6. Sue will start pricing out what the cost will be.
- 3. First Draft 2023 Festival Budget
 - a. Terri knowing the backstory is important. We need to increase ticket prices and camping tags.
 - b. Camping tags & ticket prices are entered in festival as the same line item which is not great
 - c. Candice will help Terri go through with all the data

- d. David continue to tell people that we are NOT raising the ticket price on children
- e. Vendor fees we are still the lowest art show, we should increase their fee to \$195 we think, maybe increase to \$225 for 2023, and then \$225 for 2024. We do have a nonrefundable fee of less than \$15 I think.
- f. Ann they can continue to attend for free, if they volunteer
- g. Terri how do we communicate to the masses?
 - i. Ann we should communicate that we are going to increase pricing in tickets, parking passes and camping tags. However children prices are not increasing and we continue to be the cheapest festival in UP/Michigan (?).
- h. Work backwards what do we want to have as our INCOME of the festival. We would like it to be \$37,000.
- i. Recurring donations is that festival money or no? Board no.
- j. Ann Donations towards festival, no. Grants or sponsorships towards festival, yes.
- k. Melinda If we're looking to get \$50k, take off the grant increase to \$167k, increase it by 40%.
- I. Sue we've never raised it more than \$5-\$10.
- m. The Festival needs to make us enough money that the organization itself can be sustainable.
