# Director's Report

- Thank you to each of the board members for supporting a flexible fall schedule allowing Susan to be with her new grandchildren. All is well and a regular schedule is anticipated for January,
- Office hours for December: 11,12,13,14,15,18,19,20. Total 2017 hours 1,111.25 (target was 1,100)
- Offices hours starting week of January 8: Tuesday, Wednesday and Thursday 12-6pm
- Festival ticket option with My North Tickets
- Thanks to Ron Larson we now have our large brown trailer stored at the Dead River Storage with the green trailer. Total cost is \$560 per year for both trailers.
- Office info: purchased a pencil sharpener, rent is going up to \$392.70 from \$385 when we renew our lease in February.

# **New Business**

- -My North Tickets is a regional alternative to Brown Paper Tickets. Currently, we pay 4.5% for each online ticket sales. The representative for My North Tickets is willing to visit a board meeting to discuss this further. Demographics from gate would be available if using this option. We currently have no gate ticket demographics.
- -Brief discussion on new tires vs. new trailer.
- -The board viewed and voted on the 2018 festival logo.
- -Meeting Time Change: Erin moved to change the meeting to the first Wednesday of each month after January's meeting. Katrina seconded. Motion carried.
- -Main Stage Set Changes

Doug is recommending that musician play during some set changes. Randy Kaplan (a 2018 Children's Area performer) is willing to play during some set-changes. Have the music committee and sound review. Doug

recommendation is to "cross-pollinate" Children's Area performers with Main Stage. Compile information for the Emcess. Bring Tom Dummer into this conversation. Require Area Coordinators to present information on stage on their various areas. Katrina requested a list of potential personalities and presenting at January meeting. Katrina moves to accept and implement Doug's idea to add supplemental performer in between acts at the festival starting at this year's festival. Erin seconded. Motion carried.
